She shared the Stewardship Committee developed a matrix to outline action steps for Board Members to take once any type of donation has been made to ENYES. The Board agreed a first-time donor is expecting an acknowledgement in return for their donation. As such, the Board acknowledges the following actions will be taken after a donation is made: The donor will receive a thank-you email that includes a 501(c)3 acknowledgment. The donor will receive a phone call from a Board Member within 48 hours after the donation has been posted. The donor will receive a handwritten note from a Board Member within 48 hours after the donation has been posted that includes a personal post-script message. The donor will receive a Welcome Letter with marketing materials or a 1-page FAQ with cover letter. A sample thank-you letter was distributed that Board Members can use but should include personalized quipAnthony Normore and Meegan Johnson shared examples of thank-you letters and quips.
